Hello FIRST Program Cohort 2 Institutions:

Welcome to the Faculty Institutional Recruitment for Sustainable Transformation (FIRST) Consortium. As a member of the FIRST consortium, grantee institutions will work to meet the objectives the Notice of Award from the National Institute of Minority Health and Health Disparities (NIMHD):

- 1) Coordinate FIRST program administration and conduct comprehensive evaluation of the program context, processes, and outcomes
- 2) Coordinate and facilitate the collection of the minimum set of common data elements from FIRST Cohort awardees
- 3) Coordinate the dissemination and communication of best practices in Inclusive Excellence (IE) among FIRST Cohort institutions.

A cooperative agreement from the National Institute on Minority Health and Health Disparities (NIMHD) funds the FIRST Coordination and Evaluation Center (CEC) located at Morehouse School of Medicine in Atlanta, Georgia. The CEC is led by Dr. Elizabeth Ofili, contact principal investigator, and Dr. Brian Rivers, multi-principal investigator. The CEC team at Morehouse School of Medicine is responsible for the FIRST Program coordination, evaluation communication and dissemination. The FIRST Program Evaluation Plan and Data Sharing Agreement were developed by the CEC in collaboration with FIRST Cohort institutions. The FIRST CEC meets at least weekly to ensure progress on milestones for Common metrics, data collection across FIRST Cohort sites, as well data collection training needs across the Consortium.

The FIRST Program governance structure and the function of each working group and committee are shown below:

<b>FIRST Program Governance</b>	
<b>FIRST Executive Steering Committee (FESC)</b>	The FESC is the governing body of the FIRST Program. The FESC is composed of the FIRST CEC, FIRST grantee institutions PIs/MPIs, and the NIH Program Officers and Project Scientists. The FESC meets <b>every 4th Thursday</b> to discuss updates on FIRST Program deliverables, approve FIRST Program policies, with recorded votes per governance policy. The FESC has a rotating Chair and Co-Chair elected annually by the FESC.
<b>FIRST CEC STEERING COMMITTEE (SC)</b>	The CEC Steering Committee comprises NIH Project Scientists and NIMHD Program Officers. The SC meets <b>every 3<sup>rd</sup> Thursday</b> to discuss progress of the FIRST Program, and alignment with NIH ICs priorities for the program.
<b>FIRST PI-MPI Working Group</b>	The working group (WG) is comprised of the contact PIs and the MPIs of the grantee institutions working in collaboration with the CEC on FIRST program policies, including Data Sharing Agreement and Publication policy. The PI/MPI WG meets <b>every 2nd Thursday</b> of the month to share progress, best practices, and plan agenda items for the FESC.
<b>FIRST Data and Evaluation Working Group</b>	The working group (WG) consists of the evaluators from the grantee institutions and CEC Evaluators, Informaticians, Data Scientists, and Biostatisticians. This group worked collaboratively to develop the common metrics and common data elements of the Evaluation Plan, as well as implementation process. They provide feedback to the CEC on the REDCap data collection instrument and Dataverse data sharing platform. The Data and Evaluation WG meets twice a month on the <b>2nd and 4th Thursday</b> .
<b>FIRST Faculty Core Working Group</b>	The FC WG consists of faculty core directors from Cohort institutions. The CEC MPI works collaboratively with the group to share best practices on faculty career advancement and tenure process. The Health Equity (EQ) Learning Collaboratory will support peer to peer engagement and collaboration among FIRST Cohort faculty.
<b>FIRST Communication and Dissemination Working Group</b>	The CD WG facilitates a community of practice (CoP) in inclusive excellence (IE), both institutionally and nationally. The CD WG will inform and guide the implementation of the FIRST Cohort CoP. FIRST Program publications and presentation policy will encourage and facilitate the development of high-impact, rigorous program products while ensuring the appropriate use of data, timely completion of projects, and adherence to the principles of responsible authorship. The FIRST Program website, and the Consortium wide annual meeting will support dissemination. The Louis W. Sullivan Award to an Institution for Inclusive Excellence, and the Donald E. Wilson Award to a FIRST Cohort scholar, will recognize a sustained commitment to IE and the scientific advancement of health equity.
